

OFFICE OF THE CONTROLLER OF EXAMINATIONS**PANJAB UNIVERSITY, CHANDIGARH****GUIDELINES FOR GOLDEN CHANCE EXAMINATIONS – MAY 2026**

With reference to the notification of Golden Chance Examinations for Even Semesters (2nd, 4th, 6th, 8th & 10th) vide no. 15681/CE, Dated 09.02.2026, to be conducted in April / May 2026 along with the regular examinations, the candidates appearing in the said examinations are advised to adhere to the following guidelines w.r.t. the syllabus to follow:

1. UG Courses:

- 1A. 2nd Semester: May 2025 (Syllabus 2024-25) – NON-NEP
- 1B. 4th Semester: May 2026 (Syllabus 2025-26) – NON-NEP
- 1C. 6th Semester: May 2026 (Syllabus 2025-26) – NON-NEP

2. PG Courses:

- 2A. 2nd Semester: May 2026 (Syllabus 2025-26)
- 2B. 4th Semester: May 2026 (Syllabus 2025-26)

It is also clarified that in case the subject which is to be applied is not in the current syllabus, the syllabus to follow will be of the last session it was taught and available in the syllabus and where the title and maximum marks of the subject aren't changed but the syllabus has been changed and the paper / title is still in the syllabus, new syllabus / current syllabus will be followed. If only the option number of the paper is changed or earlier it was P-I and now it is P-II but the title of the paper is still the same, new syllabus / current syllabus will be followed. This also applies to improvement of performance category.

2. Professional Courses:**Laws:**

2A. LL.B. – Syllabus to follow: 2023-24 for 2nd Semester, 2024-25 for 4th Semester and 2025-26 for 6th Semester. In case the title / subject is not in the syllabus, the syllabus to follow for those subjects will be same as per its last availability in the syllabus irrespective of the above mentioned syllabi. This also applies to improvement of performance category.

2B. B.A.LL.B / B.Com LL.B: Syllabus to follow: **2023-24 for 2nd Semester, 2024-25 for 4th, 2025-26 for 6th, 8th and 10th Semesters.** In case the title / subject is not in the syllabus, the syllabus to follow for those subjects will be same as per its last availability in the syllabus irrespective of above mentioned syllabi. Subjects where maximum marks for theory examinations are 80:20 or 60:40, the syllabus to follow will be same as per its last availability in the syllabus, e.g. if a candidate has studied and applied for the subject which has 60:40 maximum marks, the syllabus to follow will be the same as last taught / available in the syllabus.

2C: LL.M for UILS and Department of Laws:

- i.) One year LL.M for Deptt. of Laws: **Syllabus to follow 2023-24**
- ii.) One and Two year LL.M for UILS: **Syllabus to follow 2023-24 for One year LL.M and for two year LL.M: 2023-24 for 2nd Semester; 2024-25 for 4th Semester.**

2D. Engineering: Syllabus to follow: **Latest / Current syllabus**

It is also clarified that in case the subject which is to be applied is not in the current syllabus or title of the paper / paper code is changed, the syllabus to follow will be of the last session it was taught and available in the syllabus. This also applies to improvement of performance category.

Admission Year: Candidates who are applying for the Golden Chance Examinations – April / May 2026 are advised to mention their admission year very carefully while filling the details at the online portal.
